## **Residential Provider Quality Report**

Providers in the Community Mental Health for Central Michigan Provider Network undergo an on-site review process on an annual basis and an Event Verification process randomly. Every residential Provider receives either a full site review or an on-site Recipient Rights monitor. The purpose of the site review is to evaluate each Provider's achievement toward agency standards. The event verification process includes monitoring provider compliance with agency, state, federal, and accreditation standards. The data in this table represents all CMHCM residential Providers that received a full site review and/or an event verification review in FY 18. Results of the site review are being made available for review by individuals, families, advocates and the general public. The report below provides a summary of results by Provider of the areas reviewed during the period from October 1, 2017 through September 30, 2018.
