

HOW DOES HSW FIT INTO THE PERSON CENTERED PLANNING (PCP) PROCESS?

The Person Centered Planning process will develop meaningful and measurable goals with the individual.

Habilitative goals/objectives focus on the acquisition of skills necessary for the individual to function with as much self-determination and independence as possible and prevent the deceleration or regression or loss of current optimal functional status.

Potential areas include, training in personal skills essential for privacy and independence (including, but not limited to, toilet training, personal hygiene, dental hygiene, self-feeding, bathing, dressing, grooming), and the communication of basic needs.

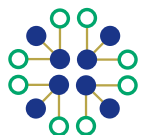

HABILITATION SUPPORTS WAIVER (HSW)

The Habilitation Supports Waiver Program (HSW) is an intensive home and community based, active treatment and support program, designed to assist individuals with intellectual/developmental disabilities to develop skills to function with as much independence as possible, and live in community based settings.

WHAT IS HSW?

The HSW is available under Section 1915(c) of the Social Security Act to provide specified home and community-based services to enrolled participants. The list of Medicaid funded services available are listed on the right-hand side of the page.

The HSW is available to individuals with active Medicaid, who meet the definition of intellectual/developmental disability, and if not for HSW services would require the level of care provided in an intermediate care facility for Individuals with Intellectual Disabilities (ICF/IID).



CRITERIA TO APPLY FOR HSW



- Has an intellectual/developmental disability as defined by Michigan law;
- Is Medicaid-eligible;
- Is residing in a community setting (with family, own home/apartment, or AFC home) ;
- If not for HSW services, would require ICF/IID level of care services;
- Chooses to participate in HSW in lieu of ICF/IID services.
